**RESOLUTION NO. 450-2020**

**DECLARING ORDINANCE NO. 6, S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION, HARASSMENT OR OTHERWISE DISCRIMINATING AGAINST A PERSON INFECTED, UNDER MONITORING OF INVESTIGATION DUE TO COVID-19 VIRUS INCLUDING PUBLIC AND PRIVATE DOCTORS, NURSES, HEALTH WORKERS, EMERGENCY PERSONNEL AND VOLUNTEERS, SERVICE WORKERS WHO ARE ASSIGNED TO HOSPITALS OR OTHER CENTERS WHERE THESE PERSONS ARE BEING TREATED AND IMPOSING THE APPROPRIATE PENALTIES THEREIN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Ordinance No. 6, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


**WHEREAS**, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated May 8, 2020, herewith attached;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 6, S- 2020 of the Sangguninag Bayan of **Bayambang**, Pangasinan, entitled “An Ordinance prohibiting any person from committing any act which causes stigma, disgrace, shame, humiliation, harassment or otherwise discriminating against a person infected, under monitoring of investigation due to COVID-19 virus including public and private doctors, nurses, health workers, emergency personnel and volunteers, service workers who are assigned to hospitals or other centers where these persons are being treated and imposing the appropriate penalties therein” as within the conferred powers of the Sangguniang Bayan to enact;
