RESOLUTION NO. 451-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-02 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASK BY ALL PERSONS IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BINALONAN, PANGASINAN DURING THE ENHANCED COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2020-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 16 and Section 458 (a) (1) (iii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks and Other Protective Equipment in Public; Provincial Ordinance No. 235-2020 (An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Enhanced Community Quarantine and For Any Extension Thereof);

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
