RESOLUTION NO. 491-2020

DECLARING ORDINANCE NO. 132, S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION, HARASSMENT, OR OTHERWISE DISCRIMINATING AGAINST A PERSON INFECTED, UNDER MONITORING OR INVESTIGATION DUE TO THE COVID-19 VIRUS INCLUDING PUBLIC AND PRIVATE DOCTORS, NURSES, HEALTH WORKERS, EMERGENCY PERSONNEL AND VOLUNTEERS, SERVICE WORKERS WHO ARE ASSIGNED TO HOSPITALS OR OTHER CENTERS WHERE THESE PERSONS ARE BEING TREATED AND IMPOSING THE APPROPRIATE PENALTIES THEREIN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 132, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) (5) (xii) of RA 7160; and Section 5 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with by the Sangguniang Bayan;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 132, S-2020 of the Sangguniang Bayan of **Basista**, Pangasinan, entitled “An Ordinance prohibiting any person from committing any act which causes stigma, disgrace, shame, humiliation, harassment, or otherwise discriminating against a person infected, under monitoring or investigation due to the COVID-19 virus including public and private doctors, nurses, health workers, emergency personnel and volunteers, service workers who are assigned to hospitals or other centers where these persons are being treated and imposing the appropriate penalties therein” as within the conferred powers of the Sangguniang Bayan to enact;
