**RESOLUTION NO. 631-2020**

**DECLARING ORDINANCE NO. 2020-11 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE STRICTLY IMPOSING MEASURES TO PREVENT THE SPREAD OF CORONAVIRUS DISEASE (COVID-19) IN THE CITY OF ALAMINOS WHILE UNDER THE GENERAL COMMUNITY QUARANTINE, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Article 2, Section 15 of the 1987 Philippine Constitution; Section 458 (xii) of RA 7160; Executive Order No. 0024-2020-A (Implementing Guidelines on General Community Quarantine in the Province of Pangasinan); and Omnibus Guidelines for the Implementation of Community Quarantine in the Philippines;

**WHEREAS**, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her opinion dated June 19, 2020;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian shall have complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;


