RESOLUTION NO. 680-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-01 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE MANDATING THE USE OR WEARING OF FACE MASK AND STRINGENT PRACTICE OF PHYSICAL DISTANCING DURING OR ON THE OCCASION OF A DECLARED NATIONAL OR LOCAL PUBLIC HEALTH EMERGENCY, EPIDEMIC OR OUTBREAK OF DISEASE TRANSMISSIBLE EITHER ORALLY OR THROUGH SNEEZING, AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2020-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (viii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places; the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines; and Executive Order No. 0033-2020 (Implementing Guidelines on Modified General Community Quarantine in the Province of Pangasinan;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated July 04, 2020;




