RESOLUTION NO. 784-2020

DECLARING MUNICIPAL ORDINANCE NO. 126-080420 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE MASKS IN PUBLIC PLACES AND STRICT PRACTICE OF PHYSICAL/SOCIAL DISTANCING BY ALL PERSONS IN THE MUNICIPALITY OF VILLASIS, PANGASINAN DURING THE ENHANCED COMMUNITY QUARANTINE OR WHILE THE THREAT OF COVID-19 IS STILL PERSISTING AND UNTIL FURTHER AMENDED OR REVOKED" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 126-080420 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; Presidential Proclamation Nos. 922 and 929, both Series of 2020; DILG Memorandum Circular No. 2020-071; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer stated in her opinion dated August 4, 2020;



RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 126-080420 of the Sangguniang Bayan of **Villasis**, Pangasinan, entitled “An Ordinance requiring the mandatory use of face masks in public places and strict practice of physical/social distancing by all persons in the Municipality of Villasis, Pangasinan during the Enhanced Community Quarantine or while the threat of COVID-19 is still persisting and until further amended or revoked” as within the conferred powers of the Sangguniang Bayan to enact;
