EXECUTIVE ORDER NO. 0009-2020

**CREATING AN INTER-AGENCY TASK FORCE FOR THE PREVENTION AND CONTROL OF
2019 CORONA VIRUS DISEASE (COVID 2019) IN THE PROVINCE OF PANGASINAN**

WHEREAS, Section 15, Article 2 of the 1987 Philippine Constitution and Section 16 of RA 7160 provide that Local Government Units within their territorial jurisdiction shall promote health and safety of the people;

WHEREAS, the Philippines is now one among the countries with confirmed cases based on the declaration of the World Health Organization and the Department of Health, and in response to the growing concern over the outbreak of coronavirus, it is imperative for the Province to implement strict monitoring and precautionary measures to address this issue;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2020-018 dated January 31, 2020 titled GUIDES TO ACTION AGAINST "CORONAVIRUS" that enjoin all LGUs to effectively intensify information education campaign against coronavirus and implement programs, projects and services that will promote the health and well-being of every Filipino.

NOW, THEREFORE, I, AMADO I. ESPINO III, Provincial Governor of Pangasinan, by virtue of the powers vested in me by law, do hereby issue this Executive Order and create an Inter-Agency Task Force for the enforcement of Precaution and Control of 2019 Corona Virus Disease in the Province of Pangasinan.

SECTION 2: FUNCTIONS

1. Implement the policies and guidelines of DOH and DILG regarding protocol relative to safety measures, prevention and control of the coronavirus.
2. Assist DOH in the conduct of contact tracing of persons arriving from coronavirus-affected countries.
3. Impose 14 days self-isolation/Quarantine period to all foreigners, residents and visitors coming from countries affected with the coronavirus.
4. Provide Logistical Assistance such as provision of PPEs and antiseptics to LGUs managing and transporting a coronavirus suspect.

5. Assist and facilitate referral of coronavirus suspects to the DOH-designated coronavirus referral center or hospital.
6. Ensure preparedness of Government hospitals in assessing coronavirus suspects.
7. Capacitate Health Workers in handling and managing coronavirus suspects.
8. Conduct intensified provincewide information campaign on coronavirus prevention, containment and control.
9. Prepare contingency plan in case of coronavirus outbreak.
10. Monitor measures and action taken by all stakeholders in the fight against coronavirus.

SECTION 3: EFFECTIVITY

This Executive Order shall take effect immediately.
