EXECUTIVE ORDER NO. 0019-2020 AN ORDER EXTENDING ANEW THE EXTREME ENHANCED COMMUNITY QUARANTINE UNTIL APRIL 21, 2020

As of 9:00 A.M. today, April 13, 2020, we recorded thirty-three (33) confirmed Covid-19 cases in our beloved Province of Pangasinan, nine (9) of whom had passed away. Nine days ago, these figures were at twenty-eight (28) and seven (7), respectively.

The increase in our number of confirmed cases (5 new positives) is relatively low compared to the previous two extensions (9 and 15 new positives, respectively). But of greater significance in the past nine days is the recovery of seven (7) former Covid-19 positives.

Thus, considering the above developments and the General Welfare, and by virtue of the powers vested upon me by law, the Extreme Enhanced Community Quarantine in the entire Province of Pangasinan (EO No. 0015-2020 and EO No. 0015-2020-B, as duly amended) which is set to expire in the midnight of April 14, 2020 is hereby extended anew up to the midnight of April 21, 2020, or until further declared.

Again, as previously declared in EO Nos. 0016-2020 and 0017-2020, respectively, all orders, rules, regulations, promulgations, circulars, and/or issuances by the Inter-Agency Task Force (IATF) and/or by concerned national government offices/agencies are hereby adopted and shall govern, and all previous issuances of the undersigned and/or by component LGUs, which are not in contravention of the IATF Resolutions and its member agencies, shall be made applicable in a supplementary manner only.

Special emphasis is hereby made on the following national regulations which, as previously declared, had been duly adopted among others, to wit: (a.) operation (maximum of 12 hours) of supermarkets, public and private wet markets, grocery stores, and other retail establishments engaged in the selling of basic necessities [as per IATF-EID Resolution No. 18, (I)], and (b.) the free, unimpeded, and unhampered transit of OFWs pursuant to IATF-EID Resolution Nos. 15 (H), 18 (F), and 22 (H), respectively.

Strict compliance is hereby enjoined.
