#### PROVINCIAL RESOLUTION NO. 1160-2020

REMINDING LOCAL GOVERNMENT UNITS TO COMPLY WITH AND IMPLEMENT EXECUTIVE ORDERS ISSUED BY THE PROVINCIAL GOVERNOR AND PROVINCIAL ORDINANCES ENACTED BY THE SANGGUNIANG PANLALAWIGAN ESPECIALLY COVID-19-RELATED MATTERS

**WHEREAS,** Section 465 of RA 7160 provides that the Provincial Governor shall issue such Executive Orders for the faithful and appropriate enforcement and execution of laws and ordinances;

WHEREAS, Section 16 of the same Code also provides that the Sangguniang Panlalawigan as the highest legislative body of the Province is mandated to enact ordinances, approve resolutions and appropriate funds for the general welfare of the inhabitants;

**WHEREAS,** Provinces with respect to component cities and municipalities shall ensure that the acts of their component units are within the scope of their prescribed powers and functions;

WHEREAS, the Office of the Governor and the Sangguniang Panlalawigan derived their existence under the law and the exercise of their respective duties and obligations which are in accordance with laws and regulations may not be disregarded;

WHEREAS, it is the aim of the Sangguniang Panlalawigan to foster a good working relationship with all the local government units under the jurisdiction of the Province:

WHEREAS, the Sangguniang Panlalawigan reminds local government units to comply with and implement Executive Orders and provincial ordinances of the Province, especially during this time that the government is exerting all efforts to protect the people from the effects of Covid-19;
