**PROVINCIAL RESOLUTION NO. 59-2021**

**AMENDING PROVINCIAL RESOLUTION NO. 372-2020 OF THE 10<sup>TH</sup> SANGGUNIANG PANLALAWIGAN ENTITLED “APPROVING AN INTERIM INTERNAL RULES OF PROCEDURE PARTICULARLY ON THE MANNER OF HOLDING OF REGULAR/SPECIAL SESSION AND COMMITTEE HEARING/MEETING DURING THIS TIME OF COVID-19 PANDEMIC”**

**WHEREAS**, Provincial Resolution No. 372-2020 provides, among others, the holding of physical sessions every first Monday of the month which shall start at 10:00 a.m. to be held at the Training Center II;

**WHEREAS**, since June 2020, the Sangguniang Panlalawigan has been holding only one physical session for every month to comply with the protocols set forth in the guidelines issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) to reduce COVID-19 transmissions;

**WHEREAS**, for the past several months, the Members of the Sangguniang Panlalawigan have been missing not only the rapport of physical legislative deliberations but also mingling with each other;

**WHEREAS**, for the year 2021 starting February, the Sangguniang Panlalawigan would like to have a more passionate and better exchange of ideas as a legislative body by holding two (2) physical sessions for every month in a very conducive and safe place for lawmakers as well as staffmembers;

**WHEREAS**, consequently, there is a need to amend the provision of the Interim Internal Rules of Procedure of the Sangguniang Panlalawigan;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Noel C. Bince, duly seconded, it was –


