# Executive Order No. 0011-2022

# IMPLEMENTING GUIDELINES ON ALERT LEVEL 2 IN THE PROVINCE OF PANGASINAN FROM FEBRUARY 16-28, 2022

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution and Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provide that Local Government Units within their territorial jurisdiction shall promote health and safety of the people;

WHEREAS, due to the nationwide spread of Corona Virus Disease 2019 (Covid-19), the Philippines is declared to be under State of Public Health Emergency and State of Calamity by President Rodrigo Roa Duterte;

WHEREAS, Executive Order No. 151 (s. 2021) issued by President Rodrigo Roa Duterte on November 11, 2021, approved the nationwide rollout of the Alert Level System and adopted the Guidelines on the Nationwide Implementation of Alert Level System for Covid-19 Response (Alert Level System Guidelines) issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID);

WHEREAS, pursuant to IATF-EID Resolution No. 161-A, Series of 2022, the Province of Pangasinan was placed in Alert Level 2 effective February 16-28, 2022;

WHEREAS, it is necessary to promulgate guidelines on the implementation of Alert Level 2 in Pangasinan, in accordance with the Alert Level System Guidelines in force and pertinent issuances of the IATF-EID and other government agencies;

**NOW, THEREFORE, I, AMADO I. ESPINO III,** Governor of the Province of Pangasinan, through the powers vested in me by law, do hereby order the following:

# SECTION 1. MINIMUM PUBLIC HEALTH STANDARDS.

- A. MPHS, or mitigation measures for Covid-19 response consistent with DOH Administrative Order No. 2021-0043, shall be implemented at all times. Such measures include but are not limited to wearing face mask and/or appropriate personal protective equipment, maintaining physical distancing, installation of hygiene stations, and ventilation for enclosed areas. Violations thereof are subject to prosecution under pertinent Provincial and local ordinances.
- B. The use of face shields shall be voluntary, without prejudice to the continuing mandatory use of face shields in medical and quarantine facility settings and the required use thereof by healthcare workers in healthcare settings.

SECTION 2. CURFEW. There shall be a province-wide curfew from 10 o'clock in the evening to 4 o'clock in the morning.





### SECTION 3. REGULATIONS ON MOVEMENT.

- A. Unvaccinated individuals or individuals with incomplete vaccinations are strongly advised to stay at home, except for emergency or humanitarian reasons.
- B. Mass gathering activities should be avoided by those with comorbidities and pregnant women, and those unvaccinated persons especially infants and children of tender years.

#### SECTION 4. BORDER CONTROL.

- A. Intrazonal and interzonal movement shall be allowed subject to reasonable restrictions that may be imposed by component LGUs. In any case, the following shall be allowed:
  - Access to obtain essential goods and services or for work in permitted industries and offices.
  - ii. Individual outdoor exercises.
- B. All tourists are encouraged to register with Pangasinan Tara Na at https://pangasinan.tarana.ph/.

### SECTION 5. OPERATING CAPACITIES OF ESTABLISHMENTS.

- A. In-person cockfighting and operation of cockpits shall be allowed subject to the following protocols under IATF-EID Resolution No. 154, s. 2021:
  - There are no objections from the LGU of the municipality/city where the inperson cockfighting may take place;
  - ii. A maximum of fifty percent (50%) venue capacity for fully vaccinated individuals only;
  - All on-site workers/employees of these establishments are vaccinated against Covid-19;
  - Betting shall be cashless and shall use technology-based platforms only i.e., no physical exchange of cash anywhere near the cockpit and no oral placing of bets;
  - v. Minimum public health standards shall be observed.
- B. The following establishments, or activities, shall be allowed to operate, or be undertaken at a **maximum of fifty percent (50%) indoor venue capacity** for fully vaccinated individuals and those under 18 years of age, even if unvaccinated, and **seventy percent (70%) outdoor venue capacity**. Provided that all on-site workers/employees of these establishments, and organizers of activities are fully vaccinated against Covid-19 and MPHS shall be strictly maintained. Provided further, that there is no objection from the LGU where these activities may take place:
  - i. Venues for meetings, incentives, conferences, and exhibitions (MICE);
  - Permitted venues for social events such as parties, wedding receptions, engagement parties, wedding anniversaries, debut and birthday parties, family reunions, and bridal or baby showers;
  - Visitor or tourist attractions such as libraries, archives, museums, galleries, exhibits, parks, plazas, public gardens, scenic viewpoints or overlooks, and the like;
  - iv. Amusement parks or theme parks;
  - Recreational venues such as internet cafes, billiard halls, amusement arcades, bowling alleys, skating rinks, archery halls, swimming pools, and similar venues;

- vi. Cinemas and movie houses;
- vii. Limited face-to-face or in-person classes for basic education subject to prior approval of the Office of the President;
- Limited face-to-face or in-person classes for higher education and for technical-vocational education and training;
- ix. In-person religious gatherings; gatherings for necrological services, wakes, inurnment, and funerals for those who died of causes other than Covid-19 and for the cremains of the Covid-19 deceased;
- x. Licensure or entrance/qualifying examinations administered by their respective government agency, and specialty examinations authorized by the IATF-EID subject to the health and safety guidelines as approved by the IATF-EID;
- Dine-in services in food preparation establishments such as kiosks, commissaries, restaurants, and eateries, subject to DTI sector-specific protocols;
- xii. Personal care establishments such as barbershops, hair spas, hair salons, and nail spas, and those offering aesthetic/cosmetic services or procedures, make-up services, salons, spas, reflexology, and other similar procedures including home service options, subject to the sector-specific protocols of the DTI;
- xiii. Fitness studios, gyms, and venues for non-contact exercise and sports, subject to DTI sector-specific protocols. Provided that patrons/clients and workers/employees wear face masks at all times and that no group activities are conducted;
- xiv. Film, music, and television production, subject to the joint guidelines as may be issued by the DTI, DOLE, and the DOH;
- xv. Contact sports approved by the LGU where such games shall be held;
- xvi. Funfairs/peryas or kid amusement industries such as playgrounds, playroom, and kiddie rides;
- xvii. Venues with live voice or wind-instrument performers and audiences such as in karaoke bars, clubs, concert halls, and theaters; and
- xviii. Gatherings in residences with individuals not belonging to the same household.
- C. An additional 10% capacity shall be allowed for establishments that have been awarded Safety Seal Certificates under the Safety Seal Certification Program.
- D. Only hotels or accommodation establishments with valid Department of Tourism Accreditation shall be allowed to accommodate guests and clients subject to guidelines issued by the Department of Tourism and the IATF-EID.
- E. All other establishments or activities not prohibited may be allowed on-site provided they implement MPHS. Establishments are encouraged to operate minimal on-site capacity thru work-from-home arrangement and other flexible work arrangements.

### SECTION 6. PUBLIC TRANSPORTATION

A. Public transport operators in Pangasinan are directed to observe seventy percent (70%) maximum passenger capacity pursuant to LTFRB Memo. Circular No. 2021-076 and Memo. Circular No. 2021-080. B. Emphasis is made on the strict implementation of minimum public health standards of passengers, drivers, and conductors in public transportation vehicles, such as but not limited to:

i. Wearing of face masks at all times;

ii. No unnecessary talking and making of phone calls;

iii. No eating while in transit;

iv. Keeping PUVs well-ventilated;

v. Conduct of frequent disinfection;

vi. No passengers with Covid-19 symptoms are to be allowed inside any public transportation vehicle;

vii. Observance of appropriate physical distancing.

**SECTION 7. SMALL-SCALE VACCINATION DRIVES.** Component LGUs are encouraged to undertake vaccination efforts by conducting small-scale vaccination drives in barangays. The conduct of information campaigns regarding the vaccines are likewise encouraged.

### SECTION 8. PENALTIES.

- A. Any violation of these Guidelines may be prosecuted under the appropriate local ordinance and/or as non-cooperation of the person or entities punishable under Section 9 par. (d) or (e), as the case may be, of Republic Act No. 11332, otherwise known as the Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act, and its Implementing Rules and Regulations.
- B. Any individual or establishment who or which will falsify any Covid-19 vaccine card shall be prosecuted under the appropriate local ordinance and/or under Act No. 3815 or the Revised Penal Code, as amended, pursuant to Section 12 of Republic Act No. 11525 or the Covid-19 Vaccination Program Act of 2021.

**SECTION 9. SEPARABILITY CLAUSE.** Should any provision of this Order be declared by a court of competent authority as invalid or unconstitutional, the remaining provisions not adversely affected thereby shall remain in full force and effect.

**SECTION 10. EFFECTIVITY CLAUSE.** This Order shall take effect immediately until or unless subsequently amended/revoked/revised. All orders, rules, regulations, promulgations, circulars, and/or issuances by the IATF and/or concerned national government offices/agencies are hereby adopted. All previous issuances of the undersigned and/or by component LGUs, which are not in contravention of the IATF Resolutions and/or its member agencies shall be made applicable in a suppletory manner.
